Official Minutes of the September 10th, 2019 Dutchess County Dental Society Executive Board Meeting

The Executive Board of the Dutchess County Dental Society met on September 10th, 2019. The meeting was at J. Dominick's Trattoria in Poughkeepsie, New York.

Board members present were:

Drs. Blondin, Jo, Kroboth, Paunovic, Prunty, Smith, Schwartz, Weiner, Dewhirst and Payami

Call to order at time: 6:54pm.

Motion: Motion passed unanimously to accept the June 2019 Executive Board minutes.

President's Report: Dr. Kroboth presided on her first board meeting as the president. Dr. Kroboth welcomed the board members and expressed excitement about the DCDS upcoming programs and venues.

Corresponding Secretary's Report: Dr. Schwartz reported. No correspondence. No letters. No inquires or new members. Dr. Schwartz requested feedback from the board members for out on a limb column.

Discussion of current secretarial positions took place. The board discussed combining and updating secretarial positions. The board also agreed that most correspondence should go through the president.

Treasurer Report: Dr. Smith reported for Dr. Rosenbloom. Treasury is in good shape.

Member Benefits Committee: Dr. Weiner reported. Association type plans are allowed under Federal Law but not under State Law. Dr. Wiener had reached out to our local government representatives but currently there is no legislative action in progress for "association group insurance".

Community Outreach and Support Committee: Dr. Smith no report.

Dutchess County Dental Society Players: Dr. Smith reported. Board will make an announcement at the DCDS general meeting to ask for volunteers for the upcoming season.

Social Events: Dr. Smith reported. The social event will be on Wednesday September 25th at Sapore Steakhouse in Fishkill.

Ninth District for Dental Health Planning and Hospital Dentistry: On August 13th, Dental Health Planning and Hospital Dentistry Committee met via video conference. Dr. Riggins reported. Dr. Tegtmeier noted that Dr. Michael Smith advised him that he'd been approached by the Mayor of Poughkeepsie about water fluoridation and that Dr. Lina Angiolillo and Dr. William Kirtland, strong advocates in Dutchess County, could be contacted to help achieve this goal. Dr. Wachs has suggested that "packing the room" of city or town hearings would go a long way to strengthen the argument in favor of passage and that this could be accomplished by asking dental students to be present. Additionally, further work is being done to aid in the formation of a managed care safety network for those with Intellectual and Development Disabilities, the last population in NYS to be moved into dental managed care by the Developmental Disabilities Dental Network Independent Practice Association, NYS Department of Health, and the Benecare Insurance Company. The NYS Task Force on Special Dentistry in conjunction with the NYS Dental Foundation have developed a new updated online program "Overcoming Obstacles to Oral Health". Dr. Paul Glassman, author of Overcoming Obstacles to Oral Health, in conjunction with the Task Force, is expected to present a program this Fall through which a pyramid of knowledge will be disseminated from oral health professionals to care-giver champions who will then pass this knowledge on to individuals with developmental disabilities.
