



### "Digital Dentistry – An Overview"

Synopsis: Digital dentistry is becoming more popular today and will soon become the standard of care in restorative dentistry. Four systems will be compared. Advantages and disadvantages for each system will be discussed. Workflow will be reviewed. CAD model manufacturing will be explained. There will be a discussion of restorative materials and case presentations.

### Leonard Patella, D.D.S.

Dr. Leonard Patella obtained his D.D.S. degree in 1988 from NYU-COD. From 1988-1990, Dr. Patella completed a two-year GPR at North Shore University Hospital, and then completed a Fellowship in Implant Dentistry from 1992-1994 from the same institution. He is also the Chief of the Division of Performance Improvement at North Shore University Hospital, a position also held since 1996. Dr. Patella is also a member of the Academy of General Dentistry. He maintains a private general dentistry practice in Garden City, New York and has utilized digital dentistry in his practice since 2005. Dr. Patella has been lecturing on this subject for the past three years.

### Official Minutes of the November 2011 Dutchess County Dental Society Executive Board Meeting

The Executive Board of the Dutchess County Dental Society met on November 8th, 2011 at Coppola's Restaurant in Wappingers Falls, New York. Board members present were: Drs. Miller, Schwartz, Walters, Prunty, Costello, Rosenbloom, Bibko, Mark and Rose Mason, Ackerman, Bonavoglia, Bloom, Kirtland, Kaplan, Blum, Smith.

The meeting was called to order by Dr. Anthony Bonavoglia at 6:40 pm.

**President's Report:** Dr. Anthony Bonavoglia requested that the board stay relevant during today's discussion. Discussion was made as to the importance of staying on task during discussions.

**Secretary's Report:** Dr. Michael Schwartz shared that the website has been getting letters regarding how to find a dentist in the area. Dr. Prunty reported that the website is going to incorporate a "tab" to find a dentist that will connect visitors to the Ninth District list of local dentists. The website committee will also look into creating a "FAQ" for people who have common questions. Dr. Schwartz mentioned that there has been a problem during General Membership Meetings with side conversations during the lecture. Dr. Bonavoglia suggested sending an email to the society to let them know about this issue. ### **EVOLUTION OF HUMAN TEETH AND JAWS: IMPLICATIONS FOR DENTISTRY** AND ORTHODONTICS

Dental caries, periodontal disease, hypoplasia, malocclusion, and impaction pose serious challenges for dentists, orthodontists, and oral surgeons. But paleontologists and bioarcheologists have found these dentognathic pathologies to be rare in traditional foragers, early human populations, and our fossil hominin forebears. The proposed NESCent Catalysis meeting will bring together evolutionary biologists, paleopathologists, biomechanists, dental researchers, food scientists, and clinicians to explore the idea that many of our dental and orthodontic problems relate to a discordance between the chemical and physical properties of our foods today and those to which our teeth and jaws evolved. The meeting will be organized around four themes: 1) evolution of the human dentognathic complex; 2) an historical perspective on dentognathic pathologies; 3) food and the oral environment; and 4) approaches to integrating evolutionary theory and clinical practice. Experts will review the "state of the science" for each theme, with time for discussion and planning of future collaborative research. Participants will be selected to represent a broad range of research and clinical interests, a diversity of backgrounds, and a variety of career stages, from emerging scientists to well-established scholars. The goal of this meeting is to catalyze the development of Evolutionary Dentistry, a discipline focused on the oral environments of our ancestors, and how an improved understanding of them can inform clinical dental and orthodontic practice.


