“Maximizing Esthetic Results by Utilizing Ceramic Enhancements and No-Prep Techniques for Porcelain Veneers”

Synopsis: This two hour lecture will demonstrate combining ideal prepped teeth for porcelain veneers and unprepared teeth with no prep enhancement veneers. No prep veneers can be the perfect alternative to traditional veneers. They are less invasive, do not require any anesthetic, more natural looking, blend with patients enamel and can be used to correct chipped or cracked teeth, close gaps, restore worn teeth and build out under contoured teeth.

Official Minutes of the November 2012 Dutchess County Dental Society Executive Board Meeting

The Executive Board of the Dutchess County Dental Society met on November 6, 2012 at Greenbaum and Gilhooley's in Wappingers Falls, New York. Board members present were: Drs. Ackerman, Baum, Bloom, Bonavoglia, Costello, Kaplan, Mark Mason, Rose Mason, Miller, Prunty, Rosenbloom, Smith, Vigliotti, Walters

Call to order at 6:51 pm

The October 2012 Executive board minutes were accepted.

President's Report: Dr. Kole Miller welcomed everyone to the meeting.

Treasurer Report: Dr. Richard Rosenbloom reported that everything is in good standing. He reminded board members that he sent a request asking for any expenses, as he will be doing the end of the year report next month. He will be analyzing the costs of this years meetings to assist the Steward in suggesting a "Season Ticket" price for next year. Dr. Rosenbloom stated that cost of meetings has gone up. In part, due to additional taxes reported by our accountants on our advertising "non-business related income" we will need to raise our Bulletin ad rates for the first time in many years.

Membership Report: Dr. Michael Smith reported we have one potential new member but is not yet ready for vote. There have been 3 new applications received.

Bulletin Committee: Dr. Manasar was not present, the deadline for the December Bulletin will be November 14.

Program Committee: Dr. Anthony Bonavoglia reported everything is in good standing for the year.

Steward's Report: Dr. John Costello reports that he is working on new venues.

Major CE Committee: Dr. Miller reported that sponsors are signing up for the all-day seminar.

Dutchess County Players: Dr. Tom Bloom reported that there are lots of schools scheduled and have been contacted by schools who are inviting the players back after having them during previous years. Dr. Baum proposed that the board invite a principal of a local school who has been very active in preventative dentistry to a general meeting and recognize her work. The board suggested we do this during February as it is National Children's Dental Health Month. Dr. Bloom wanted to thank Dr. Larry Snyder, who has been very helpful in arranging the schedule. The skit has been recently updated and they are looking for volunteers. Dr. Bloom asked the board to approve a \$400 budget to supply the players with a uniform. The motion was made and passed.

Schools and National Children's Dental Heath Month Committee: Dr. Walters was absent but sent a report stating; that she has attempted to contact both Dr. Leinkram and Dr. Goldberg about letters sent to schools in previous years. Dr. Walters was emailed new contact information as well as the website information from previous years.

Ninth District ABFM Committee: Drs. Baum reported that a budget was voted upon. The budget has little change from last year.

NYSDA Committee on Education and Licensure: Dr. Vigliotti reported that the NYSDA CDEI met in September and discussed the present situation regarding Certified Dental Assistants. NYSDA is aware that the number of certified assistants is not growing and is looking into possibilities how to address this issue.

The hope is to find a way to get more assistants certified, this could include an alternate pathway for certification other than the two that are presently offered. New Business: Dr. M. Mason reported that credit card machines have raised rates and over the phone transactions have been raised even higher.

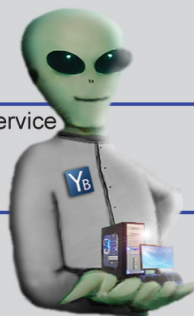
