Minutes of the January, 2007 Dutchess County Dental Society Executive Board Meeting:

The January, 2008 meeting of the DCDS Executive Board was held January 8, 2008 at Umberto's of Mamma Marissa, Poughkeepsie, NY. The meeting was called to order at 6:43 pm by President Gary Leinkram. A quorum was determined to be present. Board members in attendance were: Drs. Leinkram, Ackerman, Ross, Kaplan, Stammer, Baum, Bloom, Bonavoglia, Kirtland, M. Mason, R. Mason, Rosenbloom, Schwartz, Smith, and Vigliotti. Dr. Manasar was on a teleconference with the Ninth District's Executive Committee. Drs. Vilardi and Bailey were unable to attend. Dr. Leinkram welcomed the Board and wished everyone a Happy New Year. He praised recent work of the program committee and the web site management in particular. The minutes of the December, 2007 Executive Board meeting were accepted as published previously.

Secretary Steve Ross reported as follows:

- 1. Lists were distributed to Dr. Rose Mason who volunteered to make phone calls to those remaining members for whom we do not yet have e-mail addresses. The goal is to obtain those addresses or confirm that no e-mail address exists.
- 2. A revision of the ByLaws to conform with current practice was presented. This was reviewed and accepted by the Board. As this is a housekeeping change it is not required that it be submitted to the membership.
- β. Dr. Robert Tauber, Ninth District President, will visit the Dutchess County Dental Society at our General Membership Meeting in March.
- 4. Someone will be selected to represent the Society at the Ninth District Group Leadership Meeting on June 10.
- 5. A request from cardiologist David Weinreich was received. The Board approved his request to send us brochures for mailing to our membership promoting some cardiology education meetings. As our mailing list is not disseminated, we will do this mailing and we will receive reimbursement for the postage.

Treasurer Stephen Kaplan reported that all is well financially. 60% of member dues are paid after one week of 2008 and well as 60% of our advertisers' fees. Season Tickets to General Membership Meetings number 10 at this time. The reconciliation statement from MVP is in progress and will be completed soon.

Program Committee Chairman Don Stammer reviewed the year's upcoming GMM programs. Program speakers and subjects are in place for the full schedule through June. The list can be found on the web site under Meetings and Events.

Nominating Committee Chairman Dr. Stammer reported on the progress of nominations for the 7/1/08-6/30/09 Executive Board. The names of several potential members of the Board were presented. The next report will be made at the February Board meeting, as required.

Audio-Visual and Media Manager Gary Leinkram reported. All is well with this important function.

Schools and National Children's Dental Health Month Committee Chairman Dr. Leinkram reported that communication has begin with past participating schools for the poster contest and responses have been received. Judging is scheduled for the last week in February, and winners from Dutchess County will be forwarded to the Ninth District the first week in March.

Membership Chairman Mike Smith presented the news that two applicants have completed the process and are eligible for election to membership. The Board unanimously elected Dr. Zhi Wei Cheung and Dr. Alexandra Cernasov as Active Members of the Dutchess County Dental Society. Congratulations and welcoming letters will be sent to our newest members. Also noted is that Dr. Anthony Cacciabaudo is retiring and will leave Dutchess County. The Board approved his change of membership to Honorary under Section 5a of the ByLaws.

New **Steward** and new father Anthony Bonavoglia reported that previous Steward Scott Bailey is handling the January GMM process and that the transfer to his own Stewardship is proceeding well.

Bulletin Editor Rich Rosenbloom reported:

- 1. The deadline for the pre-February Bulletin is January 17.
- We have no new advertisers at this time.
- 3. A discussion about how to handle the transfer to electronic delivery was held and decisions were made with regard to members in various classifications who either have no e-mail addresses or have failed to supply us with one. Dual delivery (postal and e-mail) will continue through March and in April new delivery rules will begin. Members who have not supplied us with an e-mail address or notified us that they do not have e-mail will not receive a Bulletin beginning April. On-going efforts are in place to be sure that all members understand the new delivery process and to give them the opportunity to give us their e-mail address or confirm that they do not have e-mail.

Member Benefits Chairman Mark Mason reminded us that the full list of member benefits is on the web site in the Information for Members section. He urged prompt action for amalgam separator installation as required by law by May, 2008.

2008 Major CE Events Committee Chairman Dr. M. Mason reported that the meeting brochure has been mailed to our members, members of the Ninth District and neighboring districts and other groups and a second e-mail mailing was also made to our e-mail list, including past attendees. Follow-up e-mail versions are sent monthly, as previously determined. Another courtesy postal mailing to the Ninth District outside of Dutchess County will be made shortly.

Web Site Content Manager Dr. Ross reported on changes and additions to the web site made during the last month.

Helping Hand Partnership Committee Chairman Dr. Stammer reports that no new requests for assistance have been received since the last meeting, a good thing. The Partnership is ready to help at any time.

2008 BLS/ACLS course dates at Vassar Brothers Medical Center for which our Society members enjoy a significantly discounted fee were received via a report sent from Dr. Manasar. The following information will be posted on our web site under Information for Members:

- Periodic BLS certification is required for Dentists, Registered Hygienists and Licensed Certified Dental Assistants in New York State. Basic Life Support Certification courses and Renewal Courses will be given at the Tower Simulation Lab at VBMC. Both types of BLS Courses will be held monthly. The BLS Certification course fee is \$100, but because a group discount was negotiated, DCDS members will pay only \$60. BLS Renewal course fee is \$75, with DCDS members paying only \$60. For exact dates and to register call 845-431-5671. Specify membership in the DCDS.
- Advanced Cardiac Life Support Certification and Renewal Courses will be held in Conference Room B at VBMC. The Certification course will be offered in each of the months of February, April, June, September, October and December. The Renewal course will be given once monthly. The Certification fee is \$240, with DCDS members paying only \$120. ACLS Renewal course fee is \$90. For exact dates and to register call 845-431-5671. Specify membership in the DCDS.
- Additionally, Infection Control for New York State Licensed Health Care Professionals is offered as a self-study course that meets the requirements of the NYS Department of Health. Contact Staff Development at VBMC for information.

Science Fair information is not yet available.

Community Support Review Committee Chairman Dr. Vilardi sent a report that his committee will meet in very shortly to recommend recipients of Society grants for 2008.

DCDS Hall of Fame Committee work continues as reported by Dr. Schwartz. The committee will nominate a 2008 recipient for the Board's approval at the February Board meeting.

Ninth District Executive Committee member Armen Manasar sent a report of the recent NYSDA ByLaw changes, which generated significant negative comment by our Board. Once again we decry the continued dilution of membership rights to control their organization. Our Ninth District BOG Representatives Dr. Mason and Dr. Vigliotti will transmit our opinions about this when the Ninth's BOG will meets on January 29, 2008 and a report will follow at our February Board meeting.

Ninth District Council on Dental Education and Licensure: Dr. Vigliotti will report following their teleconference in February, 2008 and the corresponding NYSDA Council will meet in March, 2008.

Centennial Committee progress was reported by Dr. Kirtland. Activities continue to make this celebration a success. A teleconference will be held on January 9, 2008 and Dr. Kirtland and Dr. Mason will participate.

New Business: Dr. Bloom brought forth a suggestion that the Dutchess County Dental Society, in cooperation with the Ninth District, consider having an annual meeting similar to the Greater New York Dental Meeting. He felt that we could together do a terrific job. The Board was positive about this suggestion and interest will be explored.

NYSDA and Ninth's Bulletin: Drs. Ross and Mason confirmed that the reporting for the Dutchess County Dental Society to these Bulletins continues.

All business having been concluded and on proper motion, the meeting was adjourned at 8:15 pm. The February Executive Board meeting is scheduled for 2/5/08 at a place and time to be announced.




