Official Minutes of the January 2010 Dutchess County Dental Society Executive Board Meeting

The January, 2010 meeting of the DCDS Executive Board was held January 5, 2010 at Cappuccino by Coppola's, Poughkeepsie, NY.

The meeting was called to order at 6:39 pm by President Rosemarie Mason. A quorum was determined to be present. Board members in attendance were (alphabetically): Drs. Allen Ackerman, Irving Baum, Thomas Bloom, Anthony Bonavoglia, Stanley Kacherski, Stephen Kaplan, William Kirtland, Mark Mason, Rosemarie Mason, Richard Rosenbloom, Steve Ross, Michael J. Schwartz, Michael Smith, Frank Vigliotti, Mario Vilardi and Phil Williams. Dr. Armen Manasar was on a Ninth District teleconference and Dr. John Costello sent regrets as he was ill.

President Rosemarie Mason welcomed the Board and told the Board of one of her favorite quotations from Theodore Roosevelt, excerpted here: "It is not the critic who counts; not the man who points out how the strong man stumbles, or where the doer of deeds could have done them better. The credit belongs to the man who is actually in the arena..."

The minutes of the December 2010 Executive Board meeting were accepted as previously distributed.

Secretary Steve Ross reported:

- The Membership Spreadsheet summary was not distributed pending imminent changes expected this evening.
- 2. The Ninth District's Group Leadership Dinner Meeting is Wednesday, June 2nd.

Treasurer Stephen Kaplan reported that the DCDS remains in good financial condition. Dues payments are now at 73% and 30% of our sponsors are paid. Some sponsor information was clarified. 25 people have registered to date for the Infection Control course at Vassar Brothers Medical Center. A promotional announcement will be made at the upcoming General Membership Meeting. The Society has twice been notified of this course via e-mail.

Membership Committee Chairman Michael Smith reported receipt of a new application for membership. A discussion followed about several member classifications that need updating. Five members were dropped from the Society roll. One member was reclassified from Active Life to Retired Life. One member was reclassified from Retired Life to Honorary. Four members' classification are awaiting clarification following additional information to be obtained by Dr. Smith.

At the request of the Welcoming Subcommittee Chairman, President Mason declared the work of that subcommittee was completed and the subcommittee was dissolved. The Board expressed its appreciation to Dr. Tom Bloom for a job well done.

Bulletin Committee Chairman Rich Rosenbloom reported that the deadline for the February Bulletin is January 20th.

Program Committee Chairman Allen Ackerman reported on arrangements for upcoming meetings and will forward the information to the appropriate people per the Program Arranger's Guide.

Steward Anthony Bonavoglia will finalize venues for the remaining General Membership Meetings and communicate them to the Secretary for the web site.

New Business: Dr. Baum presented his views on the number of Executive Board meetings necessary and Dr. Mason appointed an *ad hoc* committee to study the question and present its views to the Board at the next meeting. Committee members are Drs. Baum, Kirtland, Ackerman and Mark Mason.

Dr. Baum presented two motions for consideration:

- 1. Moved that the Executive Board not hold any discussion on matters reported by our Ninth District Representatives unless the information directly affects the Dutchess County Dental Society. Motion was seconded and discussed. Motion passed by a vote of 9 YES, 6 NO, 2 Abstaining. This is effective beginning at the February Executive Board meeting.
- 2. Moved that future Dutchess County Dental Society Executive Board meetings will proceed under The Standard Code of Parliamentary Procedure by Alice Sturgis. Motion was seconded and discussed. Motion was tabled pending the President's investigation

Nominating Committee met on December 22nd. Chairman Ackerman reported the general proceedings. He reported that several members being considered for Member-at-Large nomination were to be contacted by Dr. Smith.

Member Benefits: Dr. Mark Mason reported that no new benefits have been arranged since the last report.

Major CE Events Committee: Dr. Ross reported the progress of the planning to date. It was suggested by the chair that the committee can meet immediately after the meeting to discuss a query about the Early Registration Deadline.

Web Site Content Manager Steve Ross described changes to the web site. Several problems with links were reported to Dr. Ross, and they will be repaired.

Community Outreach and Support: Chairman Dr. Vilardi reported the efforts of the Society. Dr. Bailey will care for a Tomorrow's Smiles patient.

Dutchess County Dental Society Players Director Tom Bloom reported. The next performances are scheduled for February 5 and February 12. Dr. Bloom thanked the Community Outreach and Support Committee chairman for the financial support the Players are receiving.

Fluoridation: Dr. Kirtland that no significant progress has been made since the last meeting on the issue of fluoridation.

Schools and National Children's Dental Health Month Committee Chairman Stan Kacherski reported that work is ongoing. He is being assisted by Dr. Gary Leinkram. 60 letters have been sent to Dutchess County schools advising them of the poster contest rules. Dr. Kacherski will solicit help at the upcoming General Membership Meeting for the committee's work with the posters.

Hall of Fame Committee Chairman Michael Schwartz reported that work on the nomination of a 2010 recipient will begin shortly.

Ninth District Bulletin Committee: Drs. Ross and Bloom noted that it will apparently meet twice in 2010.

Ninth District Claims Committee: Dr. Bloom reported that they are considering 4 claims.

Good & Welfare: The Executive Board congratulates Irv and Hinda Baum on the birth of their 10th grandchild; The Executive Board congratulates Alan and Shelley Viani on the birth of their 1st grandchild; Congratulations to Noreen and Frank Vigliotti on the birth of their son, Anthony John.

All business having been concluded, and on proper motion, the meeting was adjourned at 9:05 pm.


