Call to order at time: 6:53pm.

**President's Report:** Dr. Kroboth, filling in for Dr. Blondin, welcomed the board members.

**Motion:** Motion passed unanimously to accept the October 2018 Executive Board minutes.

**Corresponding Secretary's Report:** Dr. Schwartz needs input for out on a limb column. Dr. Schwartz needs program information for March 2019, deadline is January 18th. Dr. Schwartz reported that letters to new members were sent. There were no condolence letters or inquiries.


