The meeting was held at Maya Café. The meeting was attended by Dr. Ali Payami, Dr. David Chung, Dr. Michael Wiener, Dr. Joseph Blondin, Dr. Tamara Kroboth, and Dr. Richard Rosebloom. A full quorum was present for the meeting. The meeting was called to order at 6:45. Dr. Payami opened with welcome remarks and thanked everyone for attending. Dr. Payami discussed our correspondence and the Out on the Limb column for the 9th bulletin. Dr. Irving Baum will be writing the column and taking over for Dr. Schwartz. Dr. Blondin said he could help edit or contribute to the column as well. Dr. Payami said he would have Dr. Baum send his column to Dr. Blondin via email to review. The entire board expressed gratitude to Dr. Schwartz for doing such a great job previously on the column. Dr. Smith was not present to discuss the membership committee. Dr. Chung noted we have a few new applicants attending, after the meeting they will be sent membership applications to join the society. Dr. Wiener discussed that he previously suggested we get an email from the ninth district for all the Dentists in Dutchess County to send an email blast letting people know we are having CE meetings again and about the benefits of joining the society. He sent an email to Dr. Smith previously. We suggested Dr. Wiener contact Dr. Smith again to get the list and we can send out the email blast. We all agreed the sooner we can send out the information the better. If we do not hear a response from Dr. Smith Dr. Kroboth and Dr. Payami offered to follow up with the 9th to see if we could get the list. We discussed the importance of trying to get new members as well as trying to get new board members. Dr. Richard Rosenbloom discussed the treasury and presented a profit and losses sheet to the board members. During the pandemic we have operated at a net loss, and the prices for the venues and meals has increased significantly over the last 2 years. We discussed the season ticket price and the benefits. Dr. Chung mentioned the average meal price person has increased from \$40-\$50 to \$60-\$80. Dr. Kroboth made a motion to increase the season ticket fee for 2023 to \$150. Non-Dentist Auxiliary season tickets will be \$325. The board unanimously agreed, and the motion passed. Dr. Rosebloom reported that he moved the society funds from CD's to a checking/savings account. Dr. Wiener discussed the bulletin and the website, both are update date and he is waiting for the secretary's report to add to the website. The next meeting is 10/18 and the bulletin will be sent out prior to the next meeting. We did not discuss the

all-day seminar at this meeting. Dr. Chung discussed different venues and that most venues now require a per person commitment that we may have difficulty reaching. We discussed that it may be better to look at restaurants as they have the space and staff already available. The next speaker would prefer southern dutchess for a meeting and we discussed different venues that may be good. The board thanked Dr. Chung for his hard work and offered to help if he needed anything. Dr. Kroboth let the board know the meeting in October will be speakers from Hudson Valley Pediatrics and they will discuss tongue ties as well as other topics. Dr. Kroboth is looking for speakers for December, the board discussed different possibilities. The October General Meeting is on 10/18 and then the next General Meeting is on 12/6. The next board meeting will be on 11/15. Dr. Blondin spoke about AV and said the upcoming venue has a projector and screen. Dr. Blondin would like to order a Mac to HDMI connector to have for the projector, the board agreed and Dr. Blondin send a link to Dr. Rosenbloom to purchase it. The board then discussed meetings and upcoming events for the 9 th district, there was nothing new to
