- Updates on the 9th Bylaws Committee regarding the 20% nonmembers - just waiting on the board of governors and this will be the final vote

- Discussion of the bi-membership proposal/ fees associated with each membership category: There will be two classes of membership, 1) Full members and 2) Non tripartite members. Non tripartite members will incur dues of \$150 per membership year and additionally non tripartite members will not be able to vote. Full members will continue to be able to vote and will also continue to not have dues. This was voted and approved
- Season ticket costs regarding the non/tripartite members: \$125 for both classes of memberships
