DCDS Executive Board Meeting

Tuesday March 18 th, 2025

Bella Italia Restaurant

Attendance: Dr. Richard Rosenbloom, Dr. Michael Smith, Dr. David Chung, and Dr. Joseph Blondin

The meeting was called to order at 6:49 pm. Dr. Richard Rosenbloom.

The previous minutes from 11/19/24 were approved.

We reviewed the 4 new member applications, Dr. Smith let us know that we keep the applications for 1 year and then if the applicant does not attend a meeting, we remove the application and they have to submit a new one.

Dr. Rosenbloom reviewed the membership with regards to the new fee structure for non-tripartite members. We had 11 non-tripartite members, 6 renewed their membership, 1 joined the ADA, and 4 declined to renew their membership.

We discussed recruitment of new members of the board, Dr. Blondin reported he would reach out to Dr. Prunty to see if she would like to join the board again next year. We discussed obtaining email addresses for Dentists in the Dutchess County area to reach out and see we can get any new members, Dr. Smith reported he would reach out to someone at the 9 th so see if we can get a list.

Dr. Rosenbloom reported that we renewed our DNO insurance for the board. Dr. Rosenbloom reviewed the membership numbers: 5 associate members, 6 non-tripartite members, 43 retired members, and 72 tripartite members, which gives us 126 members total. We also have 36 non-members who have attended meetings previously.

Dr. Blondin reviewed the cost for having the meeting at the Lynx for June, due to the high price Dr. Blondin reported he would explore other venues to see if he can find anything more cost effective.

The board reviewed dates for the fall, we tentatively decided to have board meetings on 9/2/25 and 11/11 and the general meetings on 9/16, 10/21, and 12/9.

The meeting adjourned at 8:26 pm.
