## DCDS Meeting Minutes

Location: Cosimos

The Executive board met 8-26-25 at Cosimo's. Present for the meeting was Dr.

Mike Smith, Dr. Erin Prunty, Dr. Richard Rosenbloom, Dr. Lorry Brenner, and Dr. Joseph Blondin. Dr. Blondin ran the meeting due to Dr. Valenti's absence. The meeting was called to order at 6:34 pm. The board approved the minutes from May 13<sup>th</sup>. The board welcomed Dr. Prunty as a member-at-large. The board expressed gratitude to Dr. Lana Hashim and Dr. Emily Ennabi for joining the board as new members and reports they will continue to encourage new DCDS members to join the board at the next DCDS meeting. The board discussed reaching out via email to anyone to RSVP's as a non-member to see if they would like to join the DCDS and the board.

The board confirmed the upcoming dates for the meeting: General Meeting 9/16 at Eleven 11, General Meeting 10/21 at Longobardi's (Dr. Brenner cannot attend so Dr. Blondin will act as Steward), Executive Meeting 11/11 venue TBD by Dr. Valenti, and General Meeting 12/12 venue TBD.
